A Food Handler Safety Training card is required for people employed in or operating a food establishment as defined by NRS 446.030. It identifies the cardholder by name and photo as having completed the required food safety training.

The primary goal of the Food Handler Certification Program is to prevent foodborne illness through education. All food employees whose place of employment handles food, beverages, or utensils must obtain a Riverside County Food Handler Certificate.

Law requires all food handlers in the state of California have a California Food Handler Card. New hires have 30 days from the date of hire to obtain a card. San Diego County Code requires all food handlers to have a valid food handler card. New hires in San Diego County have the first 10 days of employment to obtain a card.
