You are required to file if your income exceeds the following limits for 2019: Single, under 65 - \$12,200. Single, 65 or older - \$13,850. Married filing jointly, both spouses under 65 - \$24,400. Married filing jointly, one spouse 65 or older - \$25,700. Married filing jointly, both spouses 65 or older - \$27,000.

Report income tax withheld on Form 945, Annual Return of Withheld Federal Income Tax, not on Forms 941 or Form 944. If the recipient is a foreign person who has provided you with Form W-8BEN, you instead must furnish a statement to the recipient on Form 1042-S, Foreign Person's U.S. Source Income Subject to Withholding, by March 15 for the prior year.
