Nevada's tax laws are intended to draw new residents and businesses to the state. Nevada has no personal income tax or corporate income tax. Since Nevada does not collect income data it cannot share such information with the federal government, the IRS. The state sales tax (similar to VAT or GST) in Nevada is variable depending upon the county. The statewide tax rate is 6.85%, with five counties (Elko, Esmeralda, Eureka, Humboldt, and Mineral) charging this amount.
